		The Review was accepted by a council Committee on 26/10/20 and a revised decision notice to agree on revised terms was published on 28/10/20.

2.4 How many assets in total have been transferred to community ownership, lease or management by your organisation since the asset transfer legislation came into force in January 2017?

While 8 asset transfer requests have been approved since the Act came into force in January 2017, none have so far been formally completed.

Glasgow City Council has had in place for many decades a number of routes through which organisations can engage with the council on asset transfer including but not limited to permissions to use, licence to occupy, lease, outright transfer etc. In recognition of the challenges for organisations of applying under the Act, the council in February 2021 launched the People Make Glasgow Communities initiative to provide a more flexible, tailored and responsive approach to asset transfer.

2.5 Please provide information on any assets transferred to community ownership *outwith* the Asset Transfer legislative process since January 2017.

On an ongoing basis, Glasgow City Council and the council family engages with community organisations and a wide range of organisations in facilitating their access to, use, and transfer of assets. Whilst formal transfers of assets are published as part of <u>council committee papers</u>, there are a much larger number of arrangements made with organisations on a continual basis.

The council has a 2 stage process for Community Asset Transfers under the Act – stage 1 is a brief initial enquiry form submitted via the Council website where basic checks are undertaken including identifying ownership of the asset/land. In stage 2 if the asset is Council owned, a formal application is issued to the Community Transfer Body. During 2020/21, we received 35 stage 1 enquiries. Some of these enquiries have gone on to stage 2 while others have not progressed, for various reasons.

The Council's website contains a range of information on Asset Transfer here. This includes detail on how to apply, the assessment process, the governance arrangements and where organisations can get support. There is also a list of current requests, decisions made and requests for review.

In addition, the People Make Glasgow Communities programme has been actively promoted through partners, social media and wider media outlets.

3.2 In particular what action has been taken to support disadvantaged communities to engage with the asset transfer process during 2020/21?

The council has provided much needed resources to enable organisations to come forward and deliver much needed services, very often, in extremely short timeframes. In the wake of the coronavirus pandemic, thousands of people have stepped up to support their local communities. People have helped neighbours and friends in need, supported key workers, and local groups and organisations have helped to get venues and facilities to open again.

Our community planning partners in the third sector and beyond have provided assistance to organisations whether in kind or, for example, via Scottish Government financial support. During 2020/21 there were a large number of initiatives aimed at providing food and supplies to Glasgow citizens and in many cases, local facilities and premises were at the heart of this provision, aided by a flexible and responsive approach by the council and partners.
