Glasgow has taken the first big steps towards producing a new local development plan which will guide future regeneration and investment in the City.

OUT FOR COMMENT UNTIL 12 DECEMBER 2012

The Main Issues Report details the 40 most important planning challenges that Glasgow is likely to face over the lifetime of the next local development plan. For each issue identified, a preferred option has been put forward along with any possible alternatives. The purpose of raising these issues is to allow everyone to have their say at the earliest stage in the development plan process on everything that is likely to be dealt with in the new plan. The issues are explored under six sustainability themes.

A Summary Booklet of Postcards and a promotional DVD (uploaded to Youtube) have also been prepared to make information more user friendly and accessible to a wider audience.

An Interim Environmental Report accompanies the Main Issues Report. It looks at the likely significant effects on the environment of implementing the proposals and alternatives, key development sites


