Takeaways and deliveries of food and alcohol accompanying food.' j) amend children and young persons access to the following: Lower Ground Floor bar & bistro: children and young persons must be accompanied by an adult in the bar & bistro. Children are allowed until 9.00pm; Young persons until 11.00pm; If attending a function within the premises, then accompanied children and young persons can remain until the end of the function. In all parts of the premises except lower ground floor bar and bistro: Accompanied children (0-15) and young persons are allowed until 7.30pm; Unaccompanied children (aged 6-15) are allowed until 6.30pm and unaccompanied young persons are allowed from 9.00am until 7.30pm; All subject to Club Rules and management discretion; and k) amend the layout of the premises to include an external drinking area in the basement area to seat 20 persons.

Variation proposes to a) remove on sales facilities; b) remove seasonal variations; c) extend off sales commencement hour from 11.00am to 10.00am on Monday to Sunday; d) remove bar meals; receptions; clubs and group meetings; live performances; dance; gaming and televised sports facilities within core licensed hours; e) allow recorded music facilities outwith core licensed hours; f) add the following to additional activities: 'Lottery/ Paypoint, sale of hot food, butchery & deli counter.
