We normally only make grant payments to legal guardians who receive Income Support, Income-based Jobseeker's Allowance, Working Tax Credit, Housing Benefit or Council Tax Benefit. We will only consider other claims in exceptional circumstances. We will usually pay grants into bank/building society accounts in July or August 2016.

**PLEASE NOTE: What we will do with your information**
