The Fresh Start scheme offers 50% rates relief for a period of 12 months on newly **occupied** properties and may be applied if all of the following circumstances are met for the property.

- The property has previously been in receipt of empty property relief for a continuous period of at least 12 months; and
- The property has a rateable value of under £65,000; and
- When last occupied, the property was used as a shop, hotel, public house, restaurant or office (as defined in the Regulations) OR the property is intended to be used as a shop, hotel, public house, restaurant or office.
- No longer than 12 months have elapsed since the lands and heritages became occupied

Please note, under regulations payday lenders will no longer qualify for Fresh Start Relief. For more information and definition of a payday lender, please visit our website - www.glasgow.gov.uk/ndr

State Aid:

Applicants should note that the Fresh Start relief for which they are applying is granted as de minimis aid for State aid purposes. There is currently a ceiling of 200,000 Euros (around £170,000, although exact amount will fluctuate) of de minimis aid that can be granted over a three year period. If you consider that you have already received in excess of, or close to, this sum over the past three years, please attach details with this application form

In view of State Aid regulations the level of relief awarded may depend on:

- a) the combined rateable value of all properties in Scotland of which your business is in rateable occupation or (if vacant) which your business is entitled to occupy;
- b) whether or not the property is eligible for one of the existing rate relief schemes; and
- c) the level of other public sector assistance received by your business (see: State aid above).
