Glasgow City Council has a dedicated **Private Landlords Support Officer** who is a point of contact for all landlords to obtain advice and support. Regular newsletters are issued provided up to date information and guidance. **You can access previous editions here.**

The Private Landlord Registration Unit and HMO Team investigate private landlords who appear to fail to meet their legal responsibilities. Where required a report will be prepared and passed to the Licensing and Regulatory Committee for their consideration. The committee will then decide based, on the evidence gathered, whether or not the landlord should be removed from the register or in the case of a HMO Licence, retain that licence.
