City Centre (Traffic Management) Order 2010 (Variation No.25) (South City Way)

Order 201

Glasgow City Council proposes to consider the introduction of the above named Traffic Regulation Order in terms of the Road Traffic Regulation Act 1984.

The order proposes to implement two way cycle tracks on Bridgegate and King Street in line with the current Strategic Plan for Cycling. The order will provide cycle and pedestrian priority to encourage sustainable transport and prioritise these options to assist in the delivery of the national Cycling Action Plan for Scotland and the targets from the Climate Change (Scotland) Act 2009. The existing motorcycle parking on Hydepark Street and Stobcross Street will be extended.

The roads affected by these proposals are bounded by: Stockwell Street, Trongate, Saltmarket and Oyde Street, they also include Hydepark Street and Stobcross Street.

The list of roads affected by these proposals are: Bridgegate, Clyde Street, Goosedubbs, Howard Street, Hydepark Street, King Street, Parnie Street and Stobcross Street.

Details of the proposals are as follows:

- 1. Provision of two way cycle track on Bridgegate
- Provision of two way cycle track on King Street Removal of metered parking on Bridgegate 2. 3.
- 4. Amendment to waiting and loading on Bridgegate
- Amendment to waiting and loading on Clyde Street 5.
- Provision of disabled vehicle parking on Clyde Street 6.
- 7. Amendment to waiting, loading and parking on King Street 8. Relocation of disabled vehicle parking from King St to Parnie St.
- Relocation of motorcycle parking from King St to Parnie St 9
- 10. Extension to motorcycle parking on Hydepark Street and
