Hi again Jackie,

Having discussed this with David from the Community Ownership Support Service, we would like to request that we meet on Tuesday the 12th of February. This gives me time to get back to work and prepare for a meeting with members of the Council. I would also like to point out to the transfer team that, if this meeting is part of due process, Beatroute Arts should have been made aware at the time of application. We would then have scheduled the meeting in advance with yourselves to fall in line with the timescales given, rather than have our decision date pushed back because-presumably-the outcome of this meeting will influence any decisions made by the Council.

With this mind, it is extremely important that Beatroute Arts are given a full agenda (including full list of questions) to be discussed at this meeting well ahead of the meeting date, and a list of Council attendees. I am uncomfortable with point 2 "Lease vs Ownership" until this has been fully explained. We would like to know exactly what this point is referring to, and whether the Council feels this point has not been fully covered in our initial application for asset transfer. It seems that it is a little late in the day to be asking for

additional information-we were under the impression that this part of the process had been concluded and the Council were satisfied with the information provided, hence the declaration of a decision date.

David Henderson will be attending the meeting with myself and colleagues. As I am off on annual leave from tomorrow, my colleague Daniella Kidd (on cc) will be picking this up in my absence and is fully informed.
