## Local issue: Potential additional housing land

In a newsletter last year I set out the position at that point on the 'Summerston Wider Area' feasibility study in relation to a proposed housing development bounded by Blackhill Road.

This feasibility study is to examine the environmental, hydrological and infrastructure issues in the larger area to the north of Summerston, including phasing and delivery, to assess the potential for additional housing land in the area.

*The feasibility study has not yet been reported to a committee of the Council.*

Notwithstanding, a planning application (reference 19/03776/PPP) has now been submitted by Caledonian Property Investments Ltd. This application is available to view via the Council's online Planning Portal.

Should you wish to make comment on the planning application, the last date for comments from the public is now Friday 21 February. Anyone wishing to make a representation must therefore do so by this date.

As I am a member of the Planning committee I may not, and will not, comment before all papers are before the Planning Committee. But you can be assured that I will give this full and proper consideration.

## My role

I was pleased to be elected as a Councillor for Maryhill ward in May 2017. Since then I have been active in pursuing issues brought to me by residents. Most people contact me by e-mail or phone but I am pleased to meet you personally, at a surgery or by appointment. **My surgery times and contact details are at the end of this newsletter.**

The Council's website provides information on its services and on reporting of problems. Online reporting is available for many environmental service issues and phone numbers are below. I attend Community Council meetings, as well as meetings of residents associations where that is requested. I am pleased to meet, work with and support the dedicated community members who give their time to such groups.

I also keep in touch with the many voluntary organisations active in Maryhill- including, but not only, Home Start, the CAB, the Women's Centre and Maryhill Integration Network.
