The area covered by these proposals has been highlighted as being negatively affected by current parking practices and this is why these proposals have been drawn up. I travel by car share with friends from to home games at Ibrox. We park in the area of In line with other supporters we park responsibly with respect to residents. We travel 5 to 6 hours return journey. There is no alternative that would not cause considerable inconvenience for a group of people who collectively bring earning to the local economy, not just at the stadium but the surrounds. The geographical area covered by the restrictions is very large and will impact almost everyone who travels to Ibrox by car or on a supporters bus. It will displace ourselves our cars and all others in similar situations It will prolong significantly the policing operation on match days with a far greater time for supporters to disperse. It will create greater risk to public safety as supporters disperse more widely. There has been exploration of alternatives such as street parking charges around the stadium, which will discourage some, but provide income for those who do take decision to pay for event parking. The proposals as they stand have been poorly thought through and appear to have been implemented without

The proposals as they stand have been poorly thought through and appear to have been implemented without any consideration for the Rangers support. The restrictions exist in isolation with no additional transport provisions being provided for supporters. Without any improvements to public transport links to the stadium, perceived issues with parking will simply be shifted to outlying areas whilst at the same time impacting supporters, particularly the elderly and disabled. If Glasgow City Council wished to impose such restrictions they should have done so cooperatively and ensured that viable alternatives were provided. This has not been the case.

These restrictions will affect not only those who travel by car but also our Rangers Supporters Clubs. The current proposals have not made adequate provision for bus parking and will impact supporters travelling to lbrox on supporters buses like myself, my family and friends from and elsewhere in Britain.



Hi

I wish to add my objection to the proposed event day parking for Ibrox Stadium and surrounding areas.

From a personal perspective, I travel with my father-in-law (73), who experiences difficulties walking (has had knee operation) (and has lift pass access at the stadium for this) - moving the parking further away will make attendance at matches more difficult., and add additional strain

From a logistical perspective,

- this proposal will push more vehicular traffic further away, and potentially increase traffic in Glasgow City Centre should there be available parking.
- Create further traffic delays on major roads beyond the event parking zone current traffic movement is often slow due to the volume of traffic, and would not be reduced by the plans.
- on match day should SPT park & ride facilities be used, this will lead to further overcrowding of a underground network which barely copes on match day. The geography of the stations ie Shields Road Ibrox from experience on the outer circle, it would be extremely difficult to board a train to Ibrox station, and unreasonable to consider travelling inner circle.
- Even travelling by Scotrail issues with congestion on the subway would be an issue also.

Overall, I do not believe that the proposals will benefit the local areas and will potentially result in a longer timeframe for all supporters leave the area.

From experience at Hampden the traffic congestion is terrible, and the queues for the train are excessive and result in overcrowded trains to Glasgow Central. (both modes of travel have been used).

I can inform you that "Consultation" and "Publication of Proposals" are stages of a traffic order process as stated within The Local Authorities' Traffic Orders (Procedure) (Scotland) Regulations 1999:

**Consultation -** Regulation 4 of this statutory instrument specifies that a consultation is to be carried out and who is to be consulted. The bodies are the emergency services, passenger transport authority, freight transport and road haulage associations, and other professional road users the authority thinks appropriate.

**Publication of Proposals -** Regulation 5 specifies how the proposals are publicised. This is where traffic orders enter the public domain. This regulation states that an order must be advertised in a local newspaper by way of a notice containing the particulars of that order and provide a copy of the documents for public perusal. Also stated in the regulation are steps that may be undertaken in addition to the minimum requirements as to extend publicity e.g. display of notices in roads or other paces affected by the order. Over 1200 notices were displayed throughout the area from 28 April until 25 May 2018.

Please note I have sent your request to the Council's Freedom of Information team to deal with under a separate cover.

I wish to register my objection to the proposed match day parking restrictions around Ibrox stadium.

Along with my family we have been travelling to matches from for over 20 years.

Due to the limitations of the public transport system it is impossible to travel to Ibrox by any other means than car.

Can you detail the improvements to the public transport infrastructure that will be put in place alongside these proposed restrictions?

The crowded nature of public transport at peak times make it very uncomfortable for the elderly, children and people with some medical issues and those groups would not be physically able to walk the long distances to the outside of the controlled zone. These parking restrictions would equate to discrimination against these groups who would feel they are no longer able to attend matches as they have for years previous. Surely this is an unacceptable situation for GCC.

We use local restaurants, shops and bars very regularly and are delighted to contribute money to these local businesses which are undoubtedly a major source of employment in the community.

Has the council considered that these parking restrictions will have an negative impact on many of these local businesses due to families ,like mine being unable to use them?

Have GCC consulted with these local businesses and taken into account the impact on local jobs?

I shall be submitting a FOI request to ascertain the level of complaints that GCC has received about the parking around Ibrox stadium. Can you tell me how many complaints it has taken for you to implement this blanket ban in the Ibrox area?

Has the GCC considered implementation of some residents parking areas rather than the blanket ban on all parking as a first step to see if this can solve any issues?

I hope that GCC will suspend the implementation of these proposals until these issues have been addressed and all other options have been explored.





This regulation states that an order must be advertised in a local newspaper by way of a notice containing the particulars of that order and provide a copy of the documents for public perusal. Also stated in the regulation are steps that may

I wish to express my objection to this proposal on the grounds that insufficient consideration has been given to the amenity of the wider community by providing alternate, low/zero-cost solutions. The stadium area on matchdays is already over capacity on all public transport routes and has been for many years, this will be further exacerbated by this proposal. The proposal unfairly discriminates against those on low-incomes and with restricted mobility (but those ineligible for a disability such as those with progressive and intermittent illness) who can today make their own travel arrangements and be parked within a short walk of the facility. For those on very low-incomes, even the typical £10 parking charge, which can only be expected to rise as you restrict supply, is a substantial portion of their disposable income.

I am currently a season ticket holder at Rangers and have been so for many years now. For every home game, I travel by car from and park around the surrounding areas of Ibrox Stadium.

With your proposals, I would be forced to either travel by train - which at cheapest a return ticket would be cost me £25.30 and then travel onwards to Ibrox by the Subway which would cost me £3.20 for a return ticket. In total this would cost me £28.50 simply to travel to Ibrox, a price that is ridiculously high. Alternatively, I could also travel by bus - which would cost me £19.50 for a ticket plus another £3.20 for a return ticket to Ibrox on the Subway, bringing a total cost of £22.70. I have travelled by Subway before and don't for one second believe there is additional capacity at the moment for the system to cope with such a large increase in the number of people using it, as it is always jam packed on match days. I wouldn't come near those prices by travelling and using the fuel in my car.

To be forced to pay these travel prices for attending every home game in my opinion is utterly ridiculous and not something I should be forced into along with many other supporters, some who may not even be able to afford it.



I have recently reviewed the proposed match day parking restrictions around Ibrox Stadium and I would like to put on record my strongest objections to the proposal.

I see no plans to upgrade the already poor public transport links which, in my opinion, should be completed prior to any restrictions being put in place. The bus and subway links will quite simply not be able to support the amount of people who currently travel by car and supporters buses from all over Scotland and further afield. I believe the numbers that will be affected to be upwards of 30,000 people.

In 2014 the Commonwealth Games meant that a number of areas were upgraded to cope with the demand of travelling fans and supporters, Celtic Park being the obvious choice for extended funding and upgraded transport infrastructure such as new roads and a new and upgraded train service/station at Dalmarnock. Perhaps re-opening the Ibrox train station on match days would assist and help alleviate some of the other transport issues I have previously mentioned. In brief, the Ibrox train station should be reinstated as a priority before any parking restrictions are implemented. This would allow for extra trains or "specials" to run on match days, before and after games, to encourage people to leave the cars at park and ride stations throughout the rail network.

I also believe these proposals have given no thought to the local businesses and will have a fatal long term impact for the area. I travel, usually by car, from out with Glasgow to all match days at Ibrox and spend a few hours in the area, using various shops and eating places, but these proposed parking restrictions will no doubt put and end to this from myself and thousands like me.

I strongly request that these restrictions are put on hold until GCC fully address better alternatives including more parking spaces for cars and supporters buses within the proposed area, better transport links including a reinstated train station and consider the impact these restrictions will have on the local business community.






