Dear Market 1

I am writing to you to note my objection to the proposals for event day parking at Ibrox Stadium. Whilst I can see why you believe this is the correct course of action, I disagree entirely. I don't believe the proposals are workable. It feels like you are trying to force through a bad idea for the sake of being seen to do something to please a minority whilst the majority become worse off.

There is no sufficient alternative public transportation options to Ibrox Stadium for the majority of supporters attending football matches. Imposing the no parking zone will only push the problem further out from the stadium, not removing it. The subway is at capacity and is only suitable for those coming from town/West End. There is no train station at Ibrox, despite one of the main lines running to Glasgow Central from Paisley/Ayr passing alongside it. Bus service for anyone not travelling along Paisley Road West is near non-existent.


The majority of supporters rely on private transport to get to Ibrox as there are no public transport options where they live. These supporters will now have to park further away from the stadium and walk for much further to get there - this will lead to a direct increase in injuries to the public. Supporters of both home and away teams in the winter months will be wetter and colder attending football and more likely to slip on one of Glasgow's many untreated footpaths. This will affect the young and the elderly the most.

You will price families out of attending football by replacing a short car journey with multiple trips via public transport. This will only line the pockets of the transport companies who run a shoddy service in Glasgow. Aside from the cost, travel times will likely increase significantly for those not on a direct path to Ibrox.

Additionally, I believe there will be a higher instance of public disorder if you force people out of their cars and into alternative transport. More people will be inclined to have a drink on their journey to the football creating a less pleasant atmosphere for supporters and other members of the public.

Until there is a train station, more bus routes and a higher frequency of service around match times to encourage people to use public transport, this proposal is totally unworkable. If this proposal is passed, it'll will not have been based on a balanced view of the issue.

Sirs

Whilst I can appreciate the reasoning behind the proposed Ibrox event parking restrictions, I am convinced that the proposed solution is utterly and completely unrealistic.

Imposing the no parking zone around Ibrox will simply move the problem further out, thereby causing upset and distress to a different set of residents. The proposed solution will have no significant impact on the numbers of people using their cars for Ibrox events because the existing public transport infrastructure is completely incapable of getting 50,000 people to Ibrox for an event. Without any proposals to significantly increase the capacity and availability of public transport, the suggestion that the public will be persuaded to leave their cars at home is completely without any foundation. Many supporters travel from a significant distance and the suggestion that they would park in multi-storey car parks in the centre of town and then find their way to Ibrox by public transport is quite literally incredible.

Your proposals would be particularly hard on the elderly and infirm who would either find themselves having to walk much further or struggling to use the completely inadequate existing public transport system.

I believe attempting to implement your proposed solution without first of all ensuring a vast improvement in public transport provision is completely unrealistic. These proposals should be consigned to the dustbin and work should commence on a producing a more sensible solution which should surely start with ensuring there is a dramatic increase in access to Ibrox by public transport on event days.

Firstly I have no objection to the introduction of restrictions to parking t allow emergency vehicle access to and from the ground, I appreciate the problems this causes and is a correct proposal. I have attended games at Ibrox from for 50 years, travelling both by supporters bus, by car, and also public transport. Use of the car was restricted to match days when either the supporters bus was not available due to match times. I have also travelled on Public transport both in my younger days (when Rangers lacked support for the running of a bus) and more recently when I have had occasion to travel to games coinciding with visits to the city for other reasons. I have to say that travelling to games on Public transport is frustrating slow and lacking in availability. For example travelling from the contract of the has to travel by train to Glasgow and then make the return journey via underground which is fine travelling to the game but a long frustrating wait for the return trip. Can you imagine how much worse this will be with the proposed changes! The option is to alight the train at section and walk to and from the ground, I suggest you try that option, apart for the distance, I have bad memories of running for my life being chased through the housing estate on the way to the station after games. As for Public transport buses, forget it, chances are that due to traffic congestion around the city you will miss the start of the game and unless you know Glasgow and where you are going you can end up hopelessly lost, have you ever tried the transport journey planner? My most recent trip to a game at the end of the season was via Public transport. I travelled to meet friends before the game and walked to the ground from a second as it was quicker than trying to use the train and walk to the underground. It was not an unpleasant walk as it was a lovely day and the area around the riverside is now a pleasant walking environment so all good, might have been different of a wet windy day though. On leaving the stadium I decided to travel by underground into the city to catch the train to a relatives house on the The queue for the underground was 6 people wide and 200 metres long so again decided side at to walk to the city centre to catch my train. A longer than expected walk but again as it was a lovely day very enjoyable, lucky I am still fit enough to do this. On arrival at Glasgow Central I tried to use the Scotrail website to work out which train to catch, again what a joke this is to try and use, this compounded by unhelpful staff at the station and problems with service cancellations left me wandering around trying to figure out which train to catch. I eventually got on the wrong train but luckily it was going in approximately the right direction and was picked up from station by relatives to save another long walk. In summary, until the Public transport links are improved I think this proposal to introduce parking zones at Ibrox is

Flawed and should be scrapped until better links are in place for transport to and more importantly form games.

We were fortunate enough to live in for 7 years and regularly attended sporting events there at the Stadium, (55000 capacity). They have restricted parking zones around the stadium similar to what is being proposed for Ibrox and due to this I never once travelled by car to events, choosing instead to travel by public

transport.

The difference in six they allow free public transport to and from events on the day of the event and for 3
hours after it finishes just by producing your entry ticket. After the event they put on extra busses and trains and
have a dedicated bus terminus below the stadium with busses having a cleared route onto the freeway and
dedicated busways. There is also a train station right next to the ground. The surprising thing to us was that it
worked very well and as well as preventing the parking problems, local businesses benefitted from patrons travelling
to events early and enjoying drinks food etc before the match, everyone was a winner. Can I suggest you look at
how they do it for an example of a good well used public transport system.
There are problems with Glasgow following (and every other City in lead due to the lack of
infrastructure, location of football grounds in Scotland etc, but until these issues are resolved then proposals such as
this should be shelved until the public transport service provision is improved and alternatives in place to offer
suitable fast reliable alternatives to using the car.





From my experience on the bus the parking is difficult & takes a long time in getting home from a congested area. When travelling by car, I don't park across the motorway to minimise the time it takes to get parked, get back on the motorway afterwards & also minimise the congestion around the ground.

At present I feel the current travel arrangements for most affect the stadium atmosphere in the last 20 minutes of the game as lots of fans start worrying about getting back to later commitments etc.

The subway is way too congested for travelling with children. The walk to the exhibition centre is ok on a summer night but terrible on a winters day or dark night when midweek games are held

The Ibrox area requires modernisation, better parking & transport arrangements, often mobile communications don't work with the crowd at the games. I may not even make the games on time as I commonly get home after 6pm and the poor/busy public transport would not allow me to make it over to the stadium in time.



I refer to the proposals to introduce extensive parking restrictions on match-days at lbrox Stadium and wish to formally register my opposition to these proposals for the following reasons:

- 1) The areas covered by these proposals are far too widespread and would cause massive transport and parking problems.
- 2) There is a distinct lack of alternative public transport facilities to cope with the obvious increase in the use of public transport should these proposals be implemented.
- 3) The absence of a rail link to Ibrox Stadium since the late 1960's seriously restricts the options for travelling by public transport. In view of the increase in the use of motor cars there is a growing need tor the return of the rail link.
- 4) The numbers of spectators travelling to ibrox far exceeds the numbers travelling to Scotstoun for rugby fixtures where there is already a 'Residents Permit' scheme in operation 51,200 compared to 7,351. I am writing to voice my objections over the plans advertised by Glasgow City Council regarding proposed parking restrictions surrounding Ibrox Stadium. I understand that the Council wishes to reduce congestion surrounding the stadium on matchdays, and I can sympathise with that goal. However I am concerned that the current plans do not make adequate provision for supporters travelling to Ibrox from areas outwith Glasgow.

Myself, my brother, and my elderly father are regular attendees at Ibrox. We travel to Ibrox from rural for every game. We travel by car. The choice to take the car is not a decision just based on convenience. My father is elderly and often in poor health. He has a limited to capacity to walk and struggles to walk any great distance. For this reason we typically try to get a space in the car park, however this is not always possible, and we often need to find parking in the surrounding area.

Given that we travel from and given my father's health situation, I do not feel that public transport would be a viable option for travelling to Ibrox. I also feel that using public transport would be particularly problematic if these plans are enacted without a significant improvement to the current transport infrastructure. Passenger volumes would inevitably rise, and I would have doubts about my father's ability to go on such a journey.

I believe that the only realistic option my family and I have of getting to Ibrox is to use a private car, and whilst I would support a more comprehensive plan (such as a park & ride scheme, for instance), the proposals in their current form will not dissuade us from bringing the car to the Ibrox area.

I find it incredulous that Glasgow City Council is actively trying to discourage revenue coming into the city. I believe that implementing this proposal is extremely unwise as there is not enough public transport to cope with the demands resulting from a match day at Ibrox.


