




I would like to object the proposed parking ban at Ibrox Stadium and the surrounding areas.

I am writing to object to the proposal of the above named order which will affect parking around Ibrox stadium.

I object on the grounds as detailed below,

 Currently the public transport to Ibrox stadium is at capacity and the congestion caused on buses, trains and the subway will only increase tenfold after the parking restrictions come into force and supporters are forced to use public transport.

- The restrictions do not consider elderly, frail and very young supporters that rely on using cars to get to the ground and are unable to walk the several miles required by the restrictions.
- The current stadium car park is at capacity with virtually no spaces available up to several hours before events start.
- If parking in and around the stadium has been an issue for the council and residents of the area then why did the council recently decide to build social housing on the derelict land adjoining Hinshelwood and Edmiston drives? The council could have built a car park and charged for its use during event days?
- Like myself, several thousand football supporters have to travel hours by car to attend events at the stadium and these restrictions will only push the vehicles further away from the stadium and affect areas that are currently unmanned during matches by police and stewards. This will also affect supporter safety when attending certain high risk matches whereby violence has been an issue in the past. This is amplified when travelling with children.
- Parking in the designated streets around the stadium on event days has been permitted for more than 40 years, on how many occasions have emergency services been affected by vehicles being parked legally?

I strongly urge you to reconsider these proposals or at least delay the decision until a full assessment can be completed with alternative plans for permanent car parks around the stadium.

While i appreciate the impact on the residents and local community, this area also benefits enormously from having all these "visitors" on a regular basis in terms of spending in the shops/ bars/ petrol stations etc.

My greatest objection however is the impact these restrictions will impose on the large number of visitors who suffer from many forms of disability. As such they need close proximity to enable them access to the stadium - the parking restrictions will remove this possibility. For many of these individuals a visit to Ibrox may be the only form of social outing and interaction they are able to experience and with no ability for them to access the stadium from nearby parking most would be unable to attend matches. I am writing to complain and object to the proposed parking restrictions around Ibrox Stadium during matchday's. Whilst it is accepted that parking in and around the Ibrox area gives some minor disruption for relatively short periods once or twice a fortnight throughout the course of the season it seems that only football fans are being targeted. I feel that I am promoting my kids sporting interest in taking them along to football matches. Both enjoy; the whole experience of going to the football and I feel GCC are making it more difficult for regular fans like me to attend matches. Kids are being pulled away from sport by other things like games consoles etc and GCC should be doing more to encourage kids into sport. Trying to promote Glasgow on the back of the commonwealth games would've been more difficult had these parking restriction been in place in 2014.

Using only myself as an example:

I live in the south of Glasgow and travel approx. 5-6 miles to commute to Ibrox. Where I live would mean a minimum of two bus journey or bus/subway combination. This does not (on paper) seem like it is too much of a hassle, however the time it takes means that it would be at least a 1 hour commute (pre match) and up to 2 hours post match. I have on occasion tried using public transport an in each case sworn I'd never do it again due to the increase in time it takes and the hassle. I understand that fans come much further afield than what I do but there is a reason why I live and work in Glasgow so that I don't have long commutes!

I have two young sons who attend with me on match days which means that walking is not a practical option. My eldest son plays school football and if we were forced to use alternative means of transport would likely mean that we would miss a large portion of Rangers games (20-30mins) when played on a Saturday. For mid week games my eldest son is given a 'late night' to attend the football but putting these parking restrictions in place means that he would get home too late to function properly at school the following day which means he would likely miss out.

I am all for improving the safety of parking however I do not see how reducing the areas in which cars can park improves safety — can someone please explain this to me? In my experience most park in safe locations and adjust their speed accordingly. Punish those that don't but not everyone.

I pay council tax and road tax to be able to use the roads and park where (on any other day) it deemed safe to do so. On match days there is undoubtedly more vehicles in this area, however this in itself does not make it unsafe. This seems like Glasgow City Council are attempting to punish the average football fan by coming up ways in which they can generate more revenue.

In addition, it is noted that no such restrictions are being proposed in around the Hampden area and it is not clear why? Is event parking safe at Hampden but not at Ibrox/Parkhead. Is there any actual evidence that enforcing this will be safer? In my opinion this is just another hidden tax.

Note

Currently bus services are nothing short of abysmal on match days. The Subway provides a better service (in terms of frequency) but in my experience football fans are crammed in like sardines on match days with little regard for safety and I genuinely feel for those using the subway who are not attending the football. I notice that the proposals have not made any attempt to improve the public transport for 'special events'.



We have many members who travel to Ibrox for home games from all over the United Kingdom and while may travel by supporters bus many more travel by car.

Travelling from Aberdeen, Birmingham, Belfast, etc by public transport can be challenging if not impossible. These fans do not have an alternative other than to travel by car and having a 15 hour round trip in a car I am sure you will agree is amazing dedication to watch a football match. To add on an additional few hours to that to park in a long term car park in the centre of Glasgow and attempt to travel the remainder of the journey to and from Ibrox by public transport as your FAQ's suggest would be totally unacceptable.

Public transport from Ibrox does not cope with the demand by supporters who use it just now, and by adding several thousand more to this would not be beneficial for anyone.

Furthermore, our members who travel by car and park in the area will use local businesses such as restaurants for food and newsagents for drinks and snacks. These businesses would lose out on the custom they rely on for every home game at lbrox.

Under the guidelines for disabled parking however I am not eligible for a blue badge as I am not severely disabled according to both the British and Scottish Government's guidelines.

If I can not take my car to Ibrox on a match day and find a suitable parking space within walking distance I will not be able to attend any games. I would not be able to travel by subway, I have tried this before however having to stand in a queue for 35 minutes is not an option for me. Travelling by bus is also not an option as I am not guaranteed to get on the first bus which comes also meaning I can be standing waiting for 15 minutes for the next bus and to not be guaranteed a seat is also not an option. I rely on being able to enjoy watching the football as sometimes due to my health its the only social contact I have.
