Subject: Proposed Parking Restrictions - Objection

I am writing to object to your proposed parking restrictions around football stadia, in particular Celtic Park.

It is an amazing experience to see the refurbishments and regeneration that has went on in the last few years in the area of Parkhead. The Commonwealth Games and Emirates Arena along with improvements to roads and the footprint of the stadium are a tribute to the modern outlook shown by Glasgow City Council and Celtic. This area now looks like a world class environment for sport and tourists.

When you add in the general house building that has gone on, the East Ends off Glasgow has undergone a transformation that we should rightly be proud of.

It is important to remember that the catalyst for this has been Celtic Football Club. Like a seed crystal, the Emirates Arena and the housing has spread around this magnificent arena to augment the East End as a sporting hub in Glasgow. It may be appropriate at this moment to recognise that it is mainly ordinary working class supporters who have sustained the presence of Celtic in the area. When the environment was derelict and sparse, these tans still attended games faithfully, pumping money into the area and sustaining a fragile economy during bad times.

But now there are 'better days' it is time to punish these people. The fans from Glasgow may find it reasonable to attend using public transport - but only individually. Families will be unable to afford to pay for public transport when they are already paying for a car. Fans from wider afield will find it infeasible to travel on a bus, train and a third journey due to expense and the time required for the journey. Living in a satellite town, I could easily get to any game through a bus, train and train journey but I could probably not get home as there would be no bus for the final leg of my home journey if it were midweek.

Midweck events will not be attended without special effort. Recently we had Central Station crippled by overhead power line failure Could you imagine this after a Champions League game? Thousands of supporters abandoned miles from home?

If parking restrictions are required, it is essential that reasonable alternatives are in place. In Germany, special trains and buses are laid on for fans for free or for a massively reduced price. To hear there has been no forward plan other than 'it's only football fans, who cares' is disappointing.

If there were clear parking zones outside the city with shuttle buses or trains to the stadium, I would back this plan 100%. The absence of any consideration for the bloodline of the economy in the East End is very disappointing but not particularly surprising from an administration that seems to patronisingly look down on working class activities.

I also hope you realise that this objection applies to the changes at Ibrox Park. I already have colleagues at work concerned about the shift of parking towards their residential area. This is just moving the problem elsewhere even though any resident buying a house in the vicinity of a sports stadium knew what they were getting into. I also wonder why similar schemes have not been suggested for concerts around Glasgow as I have often found myself queuing for longer trying to get away from the Hydro or SECC but then again, maybe the fact that these arenas are cash cows for the Council mitigates the issue.

I am a resident of and I am, in principle, in support of the EDZP scheme. However, I think that it's implementation has been poorly thought through and I have the following concerns -

- 1. There is no limit to the number of visitors' permits that a resident can obtain
- 2. There does not appear to be a limit on the number of permits that businesses and organisations can obtain. So potentially people could join an organisation simply to obtain a permit. Clearly this is open to abuse.
- 3. The visitors permits appear to be general permits rather limited to an area. So someone could obtain a permit from a resident in one part of Ibrox and park in a completely different part of Ibrox. This would make it very difficult to identify if the scheme is being abused. Permits should be clearly marked with the street where the resident lives. Will this be done?
- 4. The website Q and A states that, regards visitors' permits, " A resident can purchase as many as they require at a cost of £10 per permit, however this will be closely monitored to ensure there is no abuse of the

- system". How will the council monitor for abuse and what sanctions will they take against anyone abusing the system. Will each visitor permit have the name and address or a code to identify which resident bought the permit? Will a database be maintained of which residents have bought permits and how many?
- 5. The visitor permits are valid for 10 years. If the EDZP scheme actually makes parking worse, people with visitor permits will be able to continue parking for the next 10 years and there will be nothing that the residents or council can do. The council should issue visitor permits that are only valid for at most 1 year until the scheme has been thoroughly tested and proven to be effective.
- 6. There is no indication of how the council will monitor the scheme to assess whether it improves or worsens the parking situation.

I have recently reviewed the proposed match day parking restrictions around Ibrox Stadium and I would like to express my strongest objections to the proposal.

I have fully reviewed the plans and believe these to be restrictive, a barrier to the local businesses trading and will have a fatal long term impact for the area. I am a visitor from out with Glasgow to all match days at Ibrox and spend a large amount of money on each visit which you are placing in jeopardy. I sometimes travel with my 2 young children and my elderly uncle. Long walks to the stadium are not an option when they are with me, and the pre-existing public transport services are woefully inadequate to cope with the existing demand.

If you consider a one hour walk, followed by a rural bus journey (hourly service), followed by a train journey, followed by a Glasgow Underground journey - all with associated waiting times as well as journey times - a reasonable alternative to the car, you are clearly living in a different world with no interest in the ability of the public to attend sporting events.


While it is true that there is some traffic congestion local to the stadium at peak times, this is a transient and infrequent phenomenon which does not warrant your excessive proposals. Indeed, far from encouraging the public

into over-utilised public transport, your proposals would merely redirect any congestion to the areas on the periphery of the restricted zone.

May I say that if you do not receive 40,000 objections to these proposals, it will merely be because those who will be impacted are not yet aware of your plans. I trust that you will reconsider your proposals and abandon them for being well intentioned but wholly impracticable.

I would like to object to the Celtic Park parking proposals (and indeed the equivalent ones at Ibrox Park). They amount to unjustified discrimination against football fans. Are equivalent restrictions in place for rugby fans at Scotstoun? Concert goers at the Hydro? Compelling individuals to park out-with an exclusion zone is simply shunting cars to new areas and counter-productive. Moreover, it is compelling individuals to walk further (often in poor weather conditions).

Celtic contribute significantly to the local economy in terms of retail, tourism, hotel and hospitality. Making customers feel less compelled to visit Glasgow does not make sense.

If the council was investing adequately in public transport infrastructure this may alleviate this. However, it is not. Dalmarnock, Bridgeton and Bellgrove stations are all around 1 km from the stadium.

I would urge you to re-consider these proposals.

Club 1872 urges our members and the wider Rangers support to submit objections to the proposed match day parking restrictions around lbrox, prior to the deadline of Friday 25th May. The impact of these restrictions on the vast majority of supporters travelling to lbrox cannot be understated. The geographical area covered by the restrictions is very large and will impact almost everyone who travels to lbrox by car or on a supporters bus.

The proposals as they stand have been poorly thought through and appear to have been implemented without any consideration for the Rangers support. The restrictions exist in isolation with no additional transport provisions being provided for supporters. Without any improvements to public transport links to the stadium, perceived issues with parking will simply be shifted to outlying areas whilst at the same time impacting supporters, particularly the elderly and disabled. If Glasgow City Council wished to impose such restrictions they should have done so cooperatively and ensured that viable alternatives were provided, This has not been the case.

These restrictions will affect not only those who travel by car but also our Rangers Supporters Clubs. The current proposals have not made adequate provision for bus parking and will impact supporters travelling to lbrox on supporters buses from all over Britain.

In line with our members' vote last year, Club 1872 will be submitting an organisational objection to GCC. However we would urge individual supporters to take the time to write a short email outlining their concerns about the proposals to saferparking-ibroxstadium@glasgow.gov.uk. I would like to record my objections to the above proposals not only in relation to Celtic Park but also to the proposal for Ibrox stadium. It seems that in some instances the restrictions extend to over a mile from the ground. As 60000 people exit the ground it would result in any congestion expanding a greater distance and defeating the purpose of the plans.

There is also the issue of the local economy as many of us use the local shops in the area of football grounds. I have some impaired mobility and would find the added distance harder to cope with. I also think that families with young children would find it stressful negotiating those further distances.

In relation to keeping roads clear for emergency vehicles I must say that in many years I cannot recall an emergency vehicle being delayed by foorball crowds, we are much more responsible than your proposals imply.

I am in my 70s and been a regular attender at Celtic Park as well as away games at most of our Scottish stadia and have not seen any incidents that would cause concern.

The proposal also talks of local transport as an alternative but I am afraid my experience of bus services in and around football stadia is that they are inadequate.

I see it as another attack on the ordinary football fan and can't help but wonder if its not to do with the increase in private housing in the area of the grounds and is to do with gentrification rather than other reasons.
