I have been a resident of [REDACTED] for 25 years and would like to register my support for the implementation of the Event Day Zone parking scheme in this area. During these 25 years my family and I have been regularly subjected to the most awful verbal abuse by the football fans. Often we are left feeling intimidated and afraid to leave our house because of the fans' threatening behaviour. They show absolutely no respect for either the residents or their properties and regularly use the area as their public toilet when they will openly urinate against garden walls and have even trespassed on people's properties and urinated against garage doors. In addition they leave behind their litter in the street and also on the residents' properties. Neither the council nor Rangers football club come to clean the street after the games.

The fans also choose to ignore the current event parking restrictions on our street and will park on both sides which means that emergency vehicles do not have room to access the houses if required. This situation is serious and is an accident waiting to happen.

I would strongly urge the implementation of the proposed Event Day Zone parking.

Dear Sir,

I am a resident of [REDACTED] and would like to register my strong support for the implementation of the Event Day Zone Parking scheme in this area. Over the past 25 years we have had continuous issues with football fans attending events at Ibrox. Apart from the obvious difficulty in parking in our street the behaviour of the fans has been appalling. My family including our 4 children from a young age have been subjected to aggression and verbal abuse from the football fans on many occasions. Furthermore, they have not shown a shred of respect for the residents or their properties. They have abused our street by using it as a toilet blatantly in front of residents - for example urinating against property walls- and by leaving litter such as beer cans, still containing suspicious liquid, which is never tidied up. Additionally, the current parking restriction on event days is not working as fans choose to ignore it and park on both sides of our narrow street. This poses a significant safety issue in terms of access for residents but also in case emergency vehicles such as a fire engine needed to attend our street. Overall the current situation has been highly intolerable as well as stressful for residents. We hope the new Event Day Zone parking scheme will eliminate these awful issues support residents so that they can maintain cleanliness, safety as well as

protect their street from football fan abuse. The new scheme should however, ensure that an effective mechanism exists to allow family and friends of residents to be able to park without being abused. 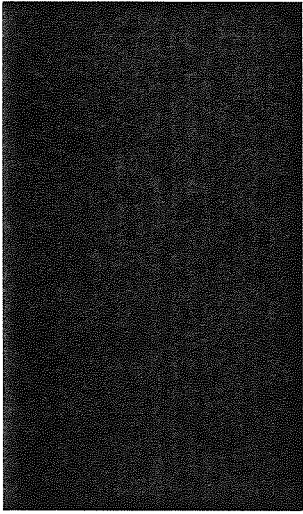
I am a resident of [REDACTED] and would like to register my strong and full support for the implementation of the proposed Event Day Zone Parking scheme in the [REDACTED] area. My family has lived in this area for 25 years, and over this period of time there has been long-standing and continuous issues in relation to football fans who attend events at Ibrox. These events create an obvious difficulty for the parking in our street and with 5 cars to our family, we are often left without parking spaces and are unable to park outside of our own house due to football fans taking these spaces. The issue does not relate only to parking but also to the verbal abuse and clear lack of disrespect from the football fans on many occasions. Being 20 years old, for as long as I can remember football fans have been rowdy and disrespectful on our street; leaving cans of beer and litter in our hedges, grown men urinating on the walls of our street and also within neighbouring properties gardens. This behaviour from the fans is a longstanding memory within my mind and is something that no child should have to witness or deal with, myself and my 3 other siblings have been subjected to this antisocial behaviour for as long as we have been in this house (my parents have lived on this street for 25 years - they have also received verbal and even racial abuse on certain occasions from the fans) and as a result my siblings and I felt very unsafe when match days arrived and dreaded when they did.

The current parking restriction on events day evidently does not work as fans chose to ignore cones and will park on both sides of the road. On more than one occasion when attempting to tell the fans that they cannot park there and the cones are there for a reason they have become aggressive towards us; on one occasion in particular my sister and I reported it to the police as the man was essentially threatening to run over my sister. The fans clear lack of disregard for the cones also poses a significant safety issue as their blatant disregard for the cones, and their subsequent parking on both sides of the road would not allow any access for emergency vehicles, such as a fire engine, if needed on our street.

We hope that the new Event Day Parking Zone Scheme will help to eradicate these obvious and longstanding issues that have been affecting this neighbourhood for many years. The new scheme should however, ensure that those living on the street and their family and friends of the residents should be able to park within their street.
