#### **Glasgow Walking and Cycling Index**

Did you know that the people of Glasgow walk or wheel the equivalent of circling the globe 33 times every day, and cycle the equivalent of 11 times around the world every day?

These findings were revealed within a new report, the Glasgow Walking and Cycling Index 2021, produced by Sustrans in partnership with the Council. The Walking and Cycling Index (WACI) is a new reporting framework from Sustrans comprehensively assessing walking, wheeling, and cycling in 17 urban areas across the UK, including Glasgow. The study also found that people walk or wheel more frequently than any other form of urban transport in Glasgow, with 53% doing so at least five or more days each week. At the recent launch event for the report, local active travel organisations gave cycling demonstrations within the former road space at the east side of George Square, which the public were able to join in.

Dr Bike provided free bike servicing and local charity Bike for Good were there to demonstrate their fleet of e-cargo bikes and provide information on their bike loan scheme. Cycling Without Age Scotland, an innovative organisation aiming to give elderly and disabled people access to the outdoors, showcased their trishaw cycles at the event. The Glenburn Centre also demonstrated the work they do in Easterhouse and the wider community by bringing along a number of their new adaptive cycles. These cycles can open up the world of cycle journeys to people of different abilities, enabling greater accessibility to active travel in the area.

The Glasgow WACI report reveals that residents would like the government to provide more funding for walking, wheeling, cycling and public transport. It further details the progress so far made in delivering

active travel infrastructure, acknowledges the challenges that remain in making active travel the first choice of transport for city residents, and highlights how GCC is already responding, particularly through its Liveable Neighbourhoods programme and Active Travel Strategy 2022-2031, which includes plans for the City Network, a 270km network of protected cycle lanes across the City.

#### Glasgow's Low Emission Zone – One Year to Go!

Plans to effectively exclude the most polluting vehicles from driving into our city centre have been given the green light after Glasgow's Low Emission Zone (LEZ) was approved by Scottish Ministers.

Now in place but with a one-year 'grace period', Glasgow's LEZ will be enforced from 1 June 2023.

It will affect all vehicles entering the zone area, with a penalty charge payable if the emission standards are not met. Those with vehicles registered to a residential address within the zone have until 1 June 2024 to prepare.

Glasgow's LEZ is an essential measure to protect public health by tackling stubbornly high levels of harmful air pollution in our city centre. Its design also supports wider climate change ambitions by encouraging a move away from private car use towards more sustainable forms of transport.

It will operate 24 hours a day - all year round and cover an area of the city centre bounded by the M8 motorway to the north and west, the River Clyde to the south and Saltmarket/High St to the east.

Road signage will be installed in the coming months to ensure that drivers are aware of the LEZ boundary and the alternative routes available to avoid the zone area if required.

## Mentoring Makes Glasgow: Hope Brings Energy. Glasgow's Women4Climate Programme

We are delighted that as part of our legacy work post COP26 that we will be taking forward Glasgow's first Women4Climate Programme as part of an established C40 mentoring programme.

C40 is a network of nearly 100 mayors of the world's leading cities who are working to deliver the action needed to confront the climate crisis and create a future where everyone, everywhere can thrive. C40's work is made possible by three strategic funders: Bloomberg Philanthropies, Children's Investment Fund Foundation (CIFF), and Realdania.

By emphasizing the inextricable link between climate change and the achievement of gender justice and equality, the Women4Climate initiative aims to help cities deliver ambitious and inclusive climate action. Women4Climate is a joint initiative of C40 Cities and the L'Oréal Foundation where women from cities can develop and implement actions inspired by the "think local, act global" philosophy. The newly established Glasgow Programme will begin post Summer 2022 for a 10 month period.

We are looking for volunteer, women mentors who can commit to the programme as detailed in the mentor guide, to work with future climate leaders in Glasgow, aged 18+.

Knowledge of sustainability/Climate and related areas of expertise would be required.

Mentees will be matched with mentors in the coming months and as we prepare for the launch we will bring together our mentors and mentees to take forward this exciting initiative. #### Single Use Plastics Ban

Scotland has become the first part of the UK to implement a ban on many of the most problematic single-use plastics, as legislation came into force last week. The ban means it will be an offence for businesses in Scotland to provide the items – which include plastic cutlery, plates and stirrers. Around 700 million of these single-use items are currently used in Scotland every year.



The regulations came into force following a six month grace period, during which Zero Waste Scotland ran a business campaign to raise awareness on how to prepare. The legislation, which was passed by the Scottish Parliament during COP26 last year, includes exemptions for single-use plastic straws, to make sure that those who need them for independent living or medical purposes can still access them.

The ban applies to single-use items including plastic cutlery (forks, knives, spoons, chopsticks), plates, straws, beverage stirrers and balloon sticks; food containers made of expanded polystyrene; and cups and other beverage containers made of expanded polystyrene, including their covers and lids. Enforcement will be the responsibility of local authorities. Failure to comply with the regulations carries a maximum fine of £5,000.



## Communities Central to Decisions on £23m infrastructure Investment

Options for a £23m package of investment in roads, lighting, footways, traffic signals and other vital infrastructure are being put before communities across Glasgow.

The Neighbourhood Infrastructure Improvement Fund will see £1m allocated for improvements in each of the city's 23 council wards with community representatives having a direct say on how the money will be spent.

Detailed proposals that provide costings and specifications for potential work are being presented to Area Partnership committee for all wards and members of the committee will then help to determine the priorities for their area. Area Partnerships bring together elected members at local and national level, community councils and other community representatives.

Investment available through the Neighbourhood Infrastructure Improvement Fund will be in addition to finance routinely available for addressing the most pressing infrastructure issues across the city. In total over £65m of investment in public roads, lighting and other infrastructure is planned for the city over the next three years.

Hillhead, Baillieston and Southside Central are among the first Area Partnerships to consider their options, but proposals for all 23 wards will be presented before the council breaks for the summer recess at the end of June. Other options to be presented include measures to prevent fly-tipping such as installing large concrete blocks and CCTV, street furniture improvements and drainage repairs.

It is expected that work identified through the Neighbourhood Infrastructure Improvement Fund will be delivered over the next two years.
