


#### National Hate Crime Awareness Week

National Hate Crime Awareness Week took place between 16 until 21 October and our 2023 campaign was Glasgow's biggest yet. You might have seen our advertising campaign on your screensaver, on the SPT Subway, or on BT Hubs around the city but awareness also needs to translate into action. We took our campaign to half term football camps and family museum days around the city to have vital conversations with families and young people about how to recognise and respond to hate crime. We were also delighted to partner with LEAP Sports to produce a <u>video</u> highlighting inclusive sports teams around the city who spoke about their experiences with hate crime and feeling excluded from sport. The week culminated in a half day conference at the City Chambers where services around the city offered their views on how to best support the victims of hate crime and encourage reporting.

Hate Crime Policy Officer, Danni Glover says "Everybody who lives in, works in, and visits Glasgow deserve to exist free from prejudice and discrimination, and the right to seek justice when they've been victimised. Last year Glasgow saw a 10 percent increase on reports of hate crime from the previous year. Each hate crime is one too many. I would urge all staff to report any hate crime they experience or witness and take the GOLD course to ensure you have the best knowledge to support the people you work with. You can also take the <a href="staff hate crime survey">staff hate crime survey</a> to tell us more about what you think."



With the support of colleagues and others across the city we have now increased MCR mentors by 200. That's 200 more young people now matched with a mentor but 100 young people are still waiting for a mentor.

Mentors come from all walks of life. You don't need specialist skills or a certain job, you don't even need to have experience of young people. Here we have a **short film** of a Glasgow youngster who was in need of a MCR mentor.

### Supporting your health and wellbeing and wellness at work as well as learning and personal development





NRS People has previously worked in partnership with the Scottish Drug Forum (SDF) to help deliver Drug and Alcohol Policy Training to over 100 NRS Managers and Supervisors during early 2023. The SDF training team, Trish Dunlop and Graham Mackintosh were delighted to be able to once again offer further sessions to NRS. 1 hour sessions were facilitated over TEAMS for just under 80 PC facing staff and also in person delivery for 50 frontline staff. Both visits to Roads and Cleansing employees at Gartcraig and Queenslie depots helped in raising awareness and provided staff with the opportunity to understand the impact of drugs and alcohol, help to remove the stigma of usage and where to find support and guidance should it be required.

- Our Employee Assistance Provider (EAP) provides this independent support to any employee affected by addictions, it is confidential and free for you to access

- Our staff health and wellbeing handbook outlines a wealth of information, advice and support on gambling, alcohol and drugs
- Our staff health and wellbeing resources guide provides access to free resources such as posters, leaflets and factsheets on alcohol consumption and drug use



How long have you worked for the council?

Assisting homeowners access Council grant funding to maintain their tenement properties to preserve our built heritage as set out in the Council's Scheme of Assistance statement. This involves working with owners, landlords, property factors, surveyors, Housing Associations, Glasgow City Heritage Trust, and Building Standards colleagues.

My other role involves approving grant funding for complex disabled adaptations for homeowners which require joint working with Glasgow Health and Care Partnership to deliver the adaptations programme via the Council's Managed Adaptations Contract awarded to City Building's Assisted Living Service.

What is your favourite part of your role?

Witnessing the transformation of buildings following major repairs and dealing with all the individuals involved in the process which can, in some instances, take years to achieve.

What are the biggest challenges within your role?

Managing homeowner's expectations as Council resources are restricted to annual budgets which make planning a large-scale programme of repairs difficult.



#### New Planning Guidance For Tall Buildings In City Centre Being Developed

Glasgow City Council is developing new planning guidance for tall buildings in the city centre which will guide decisions on their design and location.

A number of tall buildings in the city centre are currently either being constructed, have planning consent, or are proposed.

More applications for tall buildings are expected in future years as demand for housing and other uses in the city centre grows. In addition, the repurposing of existing city centre buildings will in some cases necessitate additional height to create more floorspace.

Opposing views are held on tall buildings, with supporters promoting their benefits in terms of increasing density, reducing urban sprawl and offering opportunities for refurbishment and reuse, and others suggesting they are unsustainable due to their consumption of energy and resources.

The new guidance aims to ensure that the appropriate development of tall buildings in Glasgow city centre - designed and built with care and innovation and complemented by low and medium-impact development - make the area more liveable, sustainable and diverse as it grows.

The work to develop this guidance will look at the experience of other cities; examine the topography of the city centre to assess which areas would be most affected by tall buildings; and consider how such buildings contribute to an urban planning strategy that balances economic, environmental, social and cultural aspects.

Council officers held a special meeting of the Glasgow Design Panel - with architects, designers, developers and civic and heritage bodies in attendance - to consider the topic as part of the work on the guidance.

Public consultation on tall building planning guidance will begin in Spring 2024.

A tall building is defined as a building (including roof top structures and masts) that significantly exceeds general building heights in the immediate vicinity and which alters the skyline.

#### A Vision and Plan for the Golden Z. A Creative Innovation District

Following the recent announcement of The National Lottery Heritage Fund Heritage Places initiative, Glasgow Life, in partnership with Glasgow City Council, is preparing an initial bid to resource the development of a framework and action plan that will bring together creative and culture organisations, local communities, and the city to collaborate on a vision for Sauchiehall Street.

This will lead to a long-term culture and heritage-led approach to the development of Sauchiehall Street as a creative innovation district, building on its world class assets and international fame as a hub for culture, music, film and entertainment.

An initial workshop will be held for creative, cultural and heritage organisations and businesses which are based on and around Sauchiehall Street on Tuesday 12 December 2023 at CCA. The workshop will be informed by, and respond to, previous consultations around Glasgow City Centre and, in particular, 'A Vision and Plan for the Golden Z' which encompasses Sauchiehall Street.

#### Public Urged To Turn Trash into Cash with Exciting New Litter Lotto

People in Glasgow are invited to turn trash into cash with the launch of the city's exciting new LitterLotto.

A monthly prize of £100 is up for grabs in the city's innovative new initiative to encourage more people to hin their litter

To enter, people aged 18 and over must download the free LitterLotto app to their mobile and upload photos of themselves binning rubbish in a council street bin via the app's camera function. Each month, a prize draw will see one lucky person chosen at random win a cash prize.

People can enter as many times as they like, as long as it's different litter each time being deposited into a Glasgow City Council street bin. Putting rubbish in household waste doesn't count! Leaving litter beside or on top of a bin does not qualify and if a bin is full, please find another nearby. If a blue recycling street bin is close by, please use it for anything recyclable.

Glasgow City Council is trialling LitterLotto for a year, in partnership with Keep Scotland Beautiful(KSB), to encourage more people to develop good habits.

As well as the monthly Glasgow cash prize, entrants will also be entered into a national draw for KSB's monthly £200 LitterLotto prize and LitterLotto's weekly £1000 UK-wide prize. Anyone aged 18 and over can enter if they bin a piece of litter in the city or submit a photo during an organised litter pick. The winners will be chosen at random by LitterLotto.

Participants can also collect virtual coins which are hidden in locations around the city and which can be exchanged for prizes within the app.

LitterLotto is already used by local authorities in England. South Ayrshire Council in Scotland also recently joined forces with LitterLotto to encourage behavioural change in their area. KSB has been running a Scotland-wide LitterLotto draw for over a year.
