## Lord Provost's Trust Funds – Annual accounts approved etc.

**1** There was submitted a report by the Executive Director of Finance summarising the findings of the audit for all 3 Lord Provost's Trust Funds (Older People, Vulnerable Citizens and Children's Fund) for 2021/22,

- (1) advising that the annual accounts for 2021/22 had been audited by Azets and had received an unqualified audit opinion; and
- (2) detailing in the appendices to the report, the individual audited accounts, Azets's report on each set of accounts and letters of representation which required to be signed by 1 Trustee.

After consideration, the Trustees

- (a) approved and signed the audited accounts for the 3 Lord Provost's Trust Funds (Older People, Vulnerable Citizens and Children's Fund) for 2021/22; and
- (b) noted Azets' auditor reports for each Fund.

## Minutes of previous meeting approved.

2 There was submitted the minutes of the previous meeting of 26th August 2022.

After consideration, the Trustees approved the minutes after having noted,

- that the meeting to be set up with the Lord Provost and the new Chief Executive of the Wheatley Group to discuss the possibility of an increase to their contribution to the fund had still to be organised;
- (2) that the meeting with relevant Social Work Services officers and new Trustees in order to establish a better understanding of the work involved in the allocation of the funds process had still to be organised;
- (3) an amendment to the previous minutes that should have included discussions that had taken place at the meeting with Martin Booth in relation to agreed budget allocations; and
- (4) in relation the financial update, the Trustees agreed the budgets as requested.

# Online fundraising page - Proposals agreed.

- (2) new charity donation boxes be placed in the reception area of the City Chambers and near the Banqueting Hall with the link to the webpage on the box, indicating that both cash donations and contactless payments would be accepted; and
- (3) update the Trust page on the Council website to expand upon the background to the Trust, the work it supports, the criteria and process for applications and include a link to the webpage.
