**CIVIC GOVERNMENT (SCOTLAND) ACT 1982
TAXI DRIVER'S LICENCE – SUSPENDED**

Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr Richard McKnight's taxi driver's licence (TD14146).

1 Background

- 1.1 Mr Richard McKnight was granted the renewal of his taxi driver's licence by this Authority on 10 April 2019 for a period of three years with effect from 1 February 2019 and with an expiry date of 31 January 2022 on condition that he attends a medical examination in August 2021.
- 1.2 The Licensing Section received a report from People Asset Management dated 7 December 2022 regarding Mr McKnight's fitness in terms of Group 2 standards, a copy of which will be tabled at the meeting.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr McKnight's taxi driver's licence was suspended on 24 January 2023 with immediate effect for a period of six weeks, since it was deemed that his continued taxi driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr McKnight's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
