Variation proposes to a) increase the terminal hour from 8.00pm to 10.00pm, Monday to Sunday; b) permit recorded music facilities within and outwith core licenced hours; c) add the following wording to further information, 'The premises may open for general trade prior to the commencement of core hours, but not usually before 7am. Recorded music may be played prior to the commencement of core hours. This is background level only.'; d) add the following to additional activities, 'The premises is a local convenience store and will therefore sell grocery items both during and out with core licensed hours, from 7am.
